DRILLSEARCH ANNOUNCES APPOINTMENT OF CHIEF COMMERCIAL OFFICER

Most recently, John was commercial manager for the Gloucester Basin CBM Project which was acquired in December 2009 by AGL for \$370 million from A J Lucas Group Limited and Molopo Australia Limited. His experience in developing these unconventional gas projects will be applied in furthering the commercialisation of PEL106 and developing Drillsearch's resources in the Cooper Basin.
