Mt Isa Metals Limited (ASX: MET) – Maiden Drilling Results Burkina Faso Gold Project

The Directors of D'Aguilar Gold Limited (ASX Code: DGR) are extremely pleased to draw the attention of shareholders to the recent announcement by Mt Isa Metals Limited (ASX Code: MET) regarding the receipt of initial gold assay results from its maiden RC drilling program at the Bantou Prospect in Burkina Faso.

Highlights:

- Significant gold assay results received from maiden RC drilling program at the Bantou Prospect, Dynikongolo Project area, in south-west Burkina Faso.
- Gold mineralisation defined over a 450m strike length.
- Additional strike potential remains to be tested.
- Hangingwall intersections indicate potential for multiple sub-parallel structures.
- Additional drilling planned for 2011 to test for strike extensions to defined gold mineralisation and additional targets in the broader Dynikongolo Project area.
- Initial drilling programs at Yacti and Nabanga prospects completed, assay results expected by mid January 2011.

Due to the regulatory limitations placed on D'Aguilar's ability to summarise these results, shareholders are encouraged to read the full MET announcement.

D'Aguilar Gold Limited is focused on generating exploration and development companies in a wide array of minerals.

Projects are conceived directly through the skills and experience of D'Aguilar's accomplished team of exploration geoscientists (with an enviable track record), not by the costly purchase of properties. Each project or exploration strategy is held in a separate subsidiary.

Focused and specialist management is then engaged in the subsidiary, with project specific finance raised in the subsidiary – faster and less dilutive to D'Aguilar. As the subsidiary project develops and starts to derisk the subsidiary is separately capitalised (seed raisings followed by an IPO).

Similar efforts are now being dedicated to D'Aguilar.

D'Aguilar Gold currently holds 52 million shares (37.9%) in **Mt Isa Metals Limited** (ASX: MET) embarking on an exciting gold strategy in Burkina Faso, 35.2 million shares (12.6%) in **Solomon Gold plc** (LSE: SOLG), and 58.5 million shares (53.5%) in **AusNiCo Limited** (ASX: ANW).

D'Aguilar is progressing the IPO and ASX listing of **Navaho Gold Pty Ltd** (gold and silver). Further, D'Aguilar has announced the proposed merger of its 86% owned **Ridge Exploration** (iron ore, titanium and aluminium) with Canadian-listed Coltstar Ventures Inc.

In the development pipeline, D'Aguilar is also progressing plans for other subsidiaries — **Archer Resources** (molybdenum and copper) and **Barlyne Mining** (porphyry copper, gold and molybdenum) and its energy-focused subsidiary **Armour Energy**. Several other projects are at earlier stages of development, and will be announced to the market when exploration tenements have been secured.
