SECONDARY TRADING NOTICE PURSUANT TO SECTION 708A(5) OF THE CORPORATIONS ACT 2001 (“Act”)

On 1 September 2017, Blackham Resources Limited (“**the Company**”) issued a total of 3,982,232 fully paid ordinary shares in the capital of the Company which were issued by the Company pursuant to the entering into of a Share Purchase Agreement.
