Operations

On the Group's legal suit against Soar Labs Pte Ltd, the legal proceedings are ongoing.

The Group is making good progress on its Cryptocurrency exchange and will be making its filings to AUSTRAC shortly. Pre-registration is expected to start soon.

BPG will continue to explore new and existing business opportunities for the wine distribution businesses in Asian markets, particularly with its 8 Eagles range.
