



## Emefcy Announces Second Commercial Deployment Contract in China

### Win In Competitive Tender Confirms Recognition of Emefcy Value Proposition In China

**Melbourne, Australia and Caesarea, Israel:** Emefcy Group Limited (ASX: EMC), a global leader in energy-efficient wastewater treatment solutions, today announced it entered into a binding purchase agreement with Shanghai Winner Environmental Technologies Co., Ltd (“Shanghai Winner”) to develop a commercial wastewater treatment plant in China for VOSS of Norway ASA (“VOSS”). The plant is anticipated to be the first of many in a long-term cooperation agreement between Emefcy and Shanghai Winner.

Shanghai Winner was awarded the wastewater treatment project based on Emefcy’s superior MABR solution, and Winner’s strong EPC capabilities, beating three other contenders offering the MBR technology in the competitive tender. VOSS, owned by Beijing-based Reignwood Group, is currently building a new water factory located in Shiyan in Hubei Province to support its rapid expansion in the fast-growing Chinese market, where Reignwood owns exclusive rights to Red Bull energy drinks and has a large distribution network.

Mr Richard Irving, Chairman of Emefcy, commented, “We are excited to partner with Shanghai Winner to build our second commercial deployment in China. This project win validates the superior performance of our MABR technology with a marquee client with well-established knowledge of the water sector. This project is an excellent example of our ‘packaged solution’ designed to enable a scalable business roll out in China, whereby we provide all the necessary design tools and plant specifications, plus our proprietary MABR modules, enabling our partner to assemble the wastewater treatment plant. We expect the plant to be an important reference site for us and our existing partners in China. We look forward to continuing to capitalize on the enormous market opportunity in China.”

Mr. Jack Zhang, Founder, Chairman and Chief Technology Officer of Shanghai Winner, stated, “Emefcy’s MABR solution represents a new generation in wastewater treatment technologies. The combination of being able to achieve Class 1A quality effluent at 50% lower operating costs compared to other conventional treatment methods presents tremendous value for our clients and specifically VOSS. For the past 16 years, Winner has always been in the technical forefront of implementing new processes. The cooperation with Emefcy certainly leverages our strengths and differentiated offerings to the market. We are very confident that this project will be the first of many that we will jointly execute in the future.”



Under the terms of the binding purchase agreement, Emefcy team will provide the technical information (including process and instrument drawing (P&ID), process flow diagrams (PFDs), general layout, the requisite number of MABR modules and associated controls), enabling Shanghai Winner to assemble the plant. The Emefcy engineering team will support Shanghai Winner during the installation, start-up and commissioning process.

The MABR wastewater treatment plant is expected to have a treatment capacity range of 40,000 liters per day and be commissioned by Q4 2017.
