RESIGNATION OF NON-EXECUTIVE DIRECTOR

Mustang Resources Limited ("**Mustang**" or "Company") (ASX:**MUS**) announces that Mr Peter Spiers has tendered his resignation as a non-executive Director of the Company, effective 31 December 2017.

Mr Spiers' technical, business and commercial expertise has been greatly valued by the Company.

The Board and management of Mustang would like to thank Mr Spiers for his contributions to the Board and to the development of the Company and wish him well in his endeavours for the future. He has informed the Board that he intends to pursue other business interests within the resources sector, including a new public company executive role.

His resignation means that the number of Directors will reduce from 4 to 3 for the time being. However, the Company is very well advanced in the appointment of a new Managing Director and expects to make an announcement concerning that appointment within the next 2-3 weeks.

Once the new Managing Director is appointed and Mr Ian Daymond reverts to being independent Non-Executive Chairman, the new Board will give consideration to the appointment of an additional non-executive independent director.
