## Notice given under Section 708A(5) of the Corporations Act

Mustang Resources Limited (**MUS** or **the Company**) issued 996,064 fully paid Ordinary Shares 15 January 2018. The fully paid Ordinary Shares now issued are part of the quoted securities class. These shares are subject to vesting conditions.

The Corporations Act restricts the on-sale of these Shares which have been issued without disclosure, unless the sale is exempt under Section 708 or 708A. Through the release of this Notice by Mustang Resources Limited; sale of the Securities noted above will fall within the exemption in Section 708A(5) of the Corporations Act and will be able to be traded immediately.
