Our focus is to provide venture and emerging companies with access to capital, whilst protecting investors, in a regulated, orderly, fair and transparent market. In parallel, we are targeting digitization and trading of real world assets, alongside fungible and non-fungible digital assets

Australia's dependence on (a diminishing number of) Reverse Take Overs (RTO) demonstrates the need for a market that can accommodate venture and emerging companies from diverse sectors, including high tech, agriculture, mining and fintech.

Securitisation of digitised real world assets is a significant emerging product class. Technology will allow the NSXA to specialize in fractional ownership trading of these digital products based.





**Strategic Overview:** The NSXA has and will continue to transform into a fintech servicing the ventures market.


Our services are underpinned by our technology, with continuous expansion and performance improvement our key focus.


