- Continued improving sales activity for the quarter, with \$1,370,000 in customer invoicing, plus a large order of \$400,000 signed in the first few days of April 2017.
- Operating and investing costs were \$1,835,000, compared to \$2,509,000 for the prior corresponding period. Of this amount operating costs for research, development, staff, administration and corporate costs represented \$1,480,000.
- Timing of receivables meant that cash on hand as at the end of March was \$220,000. In addition, approximately \$1,200,000 in receivables is due by the end of April 2017.
- The successful execution and maintenance of cost reduction strategies has continued, in support of the goal of achieving positive operating cash in the second half of CY2017.
- Current period working capital will be satisfied by cash on hand plus the Director's loan facility. In addition discussions with a number of major shareholders has indicated interest in further support, if required.

The Company's Board and management remain absolutely focused upon successfully monetising OtherLevels' valuable proprietary smart messaging platform in global markets, and will continue to focus on sales, maintaining reduced operational costs and the goal of achieving positive operational cash flow.
