

TAKEOVER OFFER FOR CENTRAL AUSTRALIAN PHOSPHATE LIMITED

As you may be aware, on 13 February 2013 Rum Jungle Resources Limited (the "Company") announced its intention to make an off-market takeover bid to acquire all of the ordinary shares in Central Australian Phosphate Limited ("Central Australian Phosphate").

Central Australian Phosphate is an exploration company, focused on exploration in the Northern Territory. Its project portfolio includes the Aileron Project, the Arganara Project, The Lucy Creek Project, the Strangways Project, and the Westmoreland Projects and the Warrabri Project.

The Arganara Project, which is adjacent to your company's Barrow Creek 1 Project, together, appears to form a single geological entity. The combined Measured, Indicated and Inferred Resources of this single geological entity is in excess of half a billion tonnes of phosphate rock grading $14.8\% \, P_2 O_5$.
