## Bonus Options Offer – updated timetable

Xped Limited (**ASX: XPE**) (“Xped” or “the Company”) is pleased to announce updated details of the non-renounceable pro rata offer to shareholders of one Bonus Option for every two shares held in the Company, initially announced on 18 May 2017.
