- All Australian Dyesol subsidiaries have also similarly changed their names e.g. Dyesol Industries Pty Ltd becomes Greatcell Solar Industries Pty Ltd
- All international subsidiaries are also going through the country specific legal process to change their names
- The Australian Business Number 92 111 723 883 & Australian Company Number 111 723 883 remain unchanged
- Banking details will change to reflect the name change
- The Company's existing rights and obligations, assets and liabilities are unaffected
- Greatcell Solar has secured trademarks and domain names in relevant jurisdictions to reflect the change

- No action by shareholders is required
- There are no income tax or capital gains tax implications with the change of name
- The company capital structure & the rights and obligations of shareholders are unaffected
- Issuer sponsored holdings will retain the same number
- Broker sponsored shareholdings will automatically be updated with the new name Greatcell Solar Limited when CHESS has initiated the new code change in the system
- The ASX code DYE will change to GSL on Monday 26<sup>th</sup> June 2017
- The German Börse code D5I will not change
- www.dyesol.com will transition to www.greatcellsolar.com in the coming months when website upgrades and new content will be completed
