## **BOTSWANA RENEWAL APPROVED**

Cobre Limited (ASX: **CBE**, **Cobre** or **Company**) is pleased to announce that Triprop Holdings (Pty) Limited (**Triprop**) has received notification of the renewal of the five exploration licences which are held by Triprop subject to a binding earn-in agreement with Kalahari Metals Limited (**KML**).

The five exploration licenses have been renewed for an additional two years until 30 September 2024 in accordance with the attached letter from the Department of Mines in Botswana.

**Commenting on the tenement renewal in Botswana, Cobre Executive Chairman and Managing Director Martin Holland, said:**
