	At Quarter-end, the Empire Group had a A\$7.25 million credit facility with Macquarie Bank Limited which is secured by the Company's Northern Territory assets and matures in December 2025. The credit facility is comprised of two tranches: (i) A\$2.25 million Revolving Credit Facility which carries an interest rate of BBSW+5.5% and commitment fee of 40% of the margin on undrawn amounts (drawn to A\$1.827 million as at Quarter-end); and (ii) A\$5 million Performance Bond Facility which carries an interest rate of BBSW+10.0%, commitment fee of 40% of the margin on undrawn amounts and had an outstanding balance of \$4.4 million as at Quarter-end.
