Year to date receipts from customers at item 1.1 in the attached Appendix 4C Report includes cash sales received in advance, and revenue of \$1.4 million from tunnel operations. This figure does not include pre sales from vouchers sold through our third party online promoter.

During the reporting period, the convertible note facility outstanding balance was reduced to zero using funds raised in November 2014. ISA Group's intention is to allow the convertible note facility to lapse with a zero balance.
